I am pleased that the 11th Annual Home Tour was a profitable one for the Helendale Chamber of Commerce and Scholarship Fund.

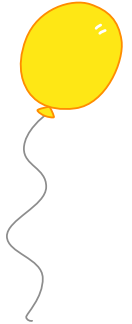
